#### **Phone in Questions**

Participants may phone in questions during this videoconference. Here are some ideas that may help you to facilitate this to the best advantage of your participants. Please share these points with your participants:

- 1. The ITV/VPC conference will focus on <u>practice issues</u> related to working with children of incarcerated parents. Please remind the participants that their questions should relate to those issues.
- 2. Questions will **not** go directly on the air but will be taken by an operator who will pass questions on to the speaker. (Due to the fact that there are many sites, all questions may not be aired). Participants can phone *anytime* during the broadcast.

- 4. Instruct participants to give their site and location by county to the operator before they ask their question.
- 5. If some participants are shy about calling in their questions themselves, you can remind them that they **won't** be live on TV **or** you can offer to call in the question for them.
