The objective of the practice model is to promote practice that is guided by values and principles and therefore increases the likelihood of positive outcomes for children, youth, families, and the community.

#### What is a Practice Model?

At its most basic level, a child welfare practice model is a conceptual map and organizational ideology of how agency employees, families, and stakeholders should unite in creating a physical and emotional environment that focuses on the safety, permanency, and well-being of children and their families
